Introducing Kinship Alliance Australia

This is the first newsletter of **Kinship Alliance Australia**, a national network of organisations and formal groups with an interest in the wellbeing of Australian kinship care families.

The Alliance is the result of a year-long collaboration between founding Directors **Mike Feszczak** (CEO of Grandcarers SA) and **Dr Meredith Kiraly**, (pro bono consultant and kinship care researcher/advocate), during which time they developed the Alliance Charter, Fact Sheet, Theory of Change and Website.

Mike and Meredith were also able to arrange meetings (with organisation representatives and carers) to lobby the *Parliamentary Friends of Grandparents and Kinship Carers (PFGKC)* cross party group in Canberra during October 2023 and March 2024, as well as many private meetings with Federal Parliamentarians including The Hon. Amanda Rishworth MP, Minister for Social

Services and also the Secretary for the Department of Social Services, Ray Griggs AO CSC.

Kinship Alliance Australia was registered in May 2024 as a national kinship care advocacy network, with the Charter describing the Alliance's purpose and objectives and its focus on all kinship care families, informal and formal, Indigenous and non-Indigenous, and all kinship relationships including relatives and family friends/connected people.

The Inaugural Meeting of the Alliance took place on Tuesday 25 June at Grandcarers SA in Adelaide, followed by lunch at the South Australian Government House, hosted by Her Excellency the Honourable Frances Adamson AC and Mr Rod Bunten (Joint Patrons of Grandcarers SA).

Visit by New Zealand grandparent/kinship care expert Kate Bundle

Our advocacy was further emphasised during the week commencing 24 June, with the visit of **Kate Bundle**, the former CEO of the NZ **Grandparents Raising Grandchildren (GRG) Trust**.

Mike and Meredith took Kate on a whirlwind speaking tour of Adelaide, Canberra (Parliament House), Melbourne and Brisbane where Kate described GRG's success in 2009 in achieving parity between the NZ foster care rate and the Unsupported Child's Benefit. This Benefit is available to all children in informal kinship care where there has been a family breakdown. New Zealand is the only country in the world with such a level of support for children in kinship care regardless of statutory status.

Kate spoke about the research, advocacy and pivotal events that came together to generate this change in government policy, one that has made a huge difference to the lives of so many families formerly living in poverty. Also included in the workshops were presentations about the purpose and objectives of Kinship Alliance Australia by Mike and Meredith.

In Adelaide 40 stakeholders heard from Kate, Meredith and Mike, whilst **Jo Sadler** (CEO of Wanslea in WA) and **Alan Hoffman** (President, Grandcarers WA) spoke about the WA state benefit for Grandparent Carers. The Parliament House presentation was opened by two informal kinship carers from New South Wales who spoke of their experiences and the challenges of caring for children who have experienced trauma. In Melbourne, the workshop was hosted by the **Mirabel Foundation** and opened by recently retired **Senator Janet Rice** (Greens) who provided valuable tips on advocacy, whilst the Brisbane workshop was hosted by **PeakCare Queensland** and facilitated by their CEO **Tom Allsop**.

We were delighted with the reception we received at each venue and being afforded events to speak about national issues impacting on kinship carers, as well as the opportunities to extend the network of Kinship Alliance Australia.

Our representatives will strive to meet regularly with the Parliamentary Friends of Grandparent and Kinship Carers and Co-Convenors **Tracey Roberts**MP (Labor), Senator Dean Smith (Liberal) and Senator Dorinda Cox (Greens) and seek action on the objectives contained in the Charter.

Conference presentations

Mike and Meredith are determined to use every opportunity to raise kinship carer topics and on 7 June presented a workshop at the Association of Children's Welfare Agencies Conference in Sydney. Entitled *Informal kinship care*, *poverty*, *and what to do about it*, the presentation described the issues facing informal kinship care families and the objectives and activities of the Alliance.

They will also present a workshop at the National Kinship, Permanent and Foster Care Conference in Melbourne on 11 August entitled *Achieving national recognition and support for all kinship care families* – *both informal and formal*.
